1 Overview

It has been recognized by the federal government that summary based crime and arrest statistics do not provide the level of detail, accuracy, and timeliness that is needed by law enforcement authorities. The National Incident-Based Reporting System (NIBRS) was developed by the FBI to overcome the shortfalls of the UCR summary-based reporting system. Full participation in the Missouri Incident Based Reporting System (MIBRS) necessitates that an agency have the data processing and other resources needed to meet all of the MIBRS validation requirements. Data extracted from agency crime incident record management systems and submitted to the state repository are more detailed than the traditional UCR Program. For this reason, increased data entry and data processing burdens are involved.

This MIBRS Technical Specifications Manual has been developed by the Missouri Uniform Crime Reporting Program in accordance with the Federal Bureau of Investigation (FBI) UCR Redevelopment Project (UCRRP). The UCRRP is the vehicle by which the FBI is modernizing its legacy mainframe-based UCR system to improve its ability to collect, analyze, and report on national crime statistics.

The new national UCR system is being enhanced to include the ability to process NIBRS data submitted in Extensible Markup Language (XML) format. However, neither the FBI UCR Program nor the Missouri UCR Program are able to accept XML formatted data at this time. For this reason, the Missouri UCR Program will only accept MIBRS data in a position-based flat-file format. New UCRRP requirements and CJIS Advisory Policy Board decisions for 2013 data collection were already incorporated into MIBRS documentation previously available in *Missouri Incident Based Reporting System Functional Specifications 2010 and MIBRS Technical Specifications Manuals v1.0 - v2.4*.


This manual is presented to give a clear understanding of what an agency / vendor must provide to the Missouri Highway State Patrol (MSHP) for crime incident data acceptance to the MIBRS state repository. The documented process centers on the production of a set of files to be sent to MSHP and highlights how these file layouts correspond to the MIBRS edits that should be performed in order to validate the data. **Although much effort has been expended to finalize the data specifications and significant changes are not anticipated, users of this document should understand that changes might still occur as a result of testing.**

Agencies and vendors are encouraged to use this manual for construction of computer applications that extract crime incident data from existing record management systems to be submitted to the MIBRS state repository. By utilizing element codes, field / cross edits, and validation rules described, programmers can ensure crime incident data will be accepted into the repository. This manual also provides programmers with code tables that can be used for default incident information to be initially populated into their applications that will improve the data entry process and reduce data entry error.

2 Business Rules

Specific business rules must be adhered to for successful submission of MIBRS data to the repository. Agencies must follow State accepted file nomenclature, file formatting, record actions, record segment specifications, and electronic transfer methods to expedite the MSHP's processing of MIBRS data. Required business rules for each of these are described below. By using this automated approach and business rules, improved crime incident collection / submission, quality of data, administration / clerical processing, and reduction of data submission backlog will be realized.

2.1 Processing Flowchart



2.2 File Submission

The MSHP will only accept submitted files that have the filename format as:
nnnnnnnnnyyyymmddhhmmvvvf.txt

Where:

nnnnnnnnn = Submitting Agency ORI

yyyy = Year submission file created

mm = Month submission file created

dd = Calendar day submission file created

hh = Hour submission file created

mm = Minute submission file created

vvv = version of file specification. The current version is 2-00

f = format. The only valid code for f is f=flat file.

The submission file should be formatted as a fixed length text file following element positioning described in Section 4 of this manual.

Data may be submitted by logging into <http://www.mshp.dps.missouri.gov/CJ56Web/login.jsp> or monthly via e-mail. This section describes the data submission format.

2.3 Segments

2.3.1 Segment Levels

Incident Reports are submitted to the MIBRS repository using up to eight distinct records, each of which is referred to as a level “segment”. The 58 numbered data elements and 11 structural data elements comprising a NIBRS data submission are grouped into eight distinct Segment Levels identified as Levels 0 – 7. Each segment must be identified by specifying the Segment Level data value. These values are identified in Section 3.1, Header Data Elements, and Segment Level.

Agencies are responsible for ensuring that all Group A Incident Report data for the LEAs that report to them are grouped in a submission by ORI (Data Element 1) and that the individual segments making up each Incident Number (Data Element 2) within the ORI are in sequence by Segment Level.

It is acceptable that the different ORIs themselves are not in sequence and that the different Incident Numbers are not in sequence within the submitted ORI.

It is not acceptable to intersperse Zero Report Segments (Level 0) and Group B Arrest Report Segments (Level 7) between Group A Incident Report segments (Levels 1 – 6).

Level 1 – Administrative Segment

Level 2 – Offense Segment

Level 3 – Property Segment

Level 4 – Victim Segment

Level 5 – Offender Segment

Level 6 – Arrestee Segment

Level 7 – Group B Arrest Report Segment

Level 0 – Zero Report Segment

An incident report may consist of many possible combinations of circumstances ranging from one simple offense, victim, and offender to a complex set of multiple offenses, property losses, victims, offenders, and arrestees. Additionally, each victim may not be involved in each offense, and one, some, or all of the victims may be connected to one, some, or all of the applicable offenses. Complete descriptions of each segment are provided in Section 3 of this manual.

2.3.2 Segment Length

Each segment in a Group A Incident Report has its own fixed length, defined in the Header Data Element "Segment Length." For example, an Administrative Segment (Level 1) with Cargo Theft must include 100 characters of data.

2.3.3 Data Records Must Be Initialized To Blanks

Each record written to a submission must first be initialized to "BLANKS" before data are moved into the applicable fields. This will provide filler for those varying Data Elements that do not have data because of the circumstances of the report or that are no longer used in the NIBRS.

2.3.4 Codes must be Right Justified with Zero Left Fill

Fields containing numeric data codes should be right-justified with zero left-fill when there is data to be reported. For example, when Property Description code is Buses (05), data value "05" would be entered, not "5b/" or "b/5" (b/ = blank).

The field should be filled with blanks when no data are to be reported.

2.3.5 Victim/Offender/Arrestee Sequence Numbers Can Have Gaps

Multiple Victim, Offender, and Arrestee Segments can have gaps in values entered into Data Elements 23 (Victim Sequence Number), 36 (Offender Sequence Number), and 40 (Arrestee Sequence Number). For instance, when four Offender Segments are submitted, the sequence numbers would normally be 01, 02, 03, and 04; but could be 02, 03, 05, and 07.

The gaps in numbers could occur, for instance, where all offenders are initially entered into the LEA's database with consecutive sequence numbers. Then, one of the offenders is subsequently deleted, thus possibly leaving a gap in the sequence numbers. Forcing a renumbering of these numbers would be a complicated process, especially when multiple victims would have to be adjusted to reflect the renumbered offender numbers in Data Element 34 (Offender Number to be related).

2.3.6 Segment Action Types

An agency can submit MIBRS data to the state repository by using three segment action types: Add (A), Modify (M), and Delete (D). Segment Action Type is a one-character alphabetic field. This data element identifies the processing to be performed by the system in relation to the specified segment and is located at the beginning of each segment in the Header Data Elements. These values are introduced in Section 3.1, Header Data Elements; Segment Action Type. These are described below:

2.3.6.1 A=Add

Segment Action Type of "A" adds a record to the repository. "A" is used to submit incident data for the first time.

Applies to:

- Group A Incident Report
- Level 1 – Administrative Segment

Description:

This value is used to submit all known data at the time a Group A Incident Report is initially submitted.

- Group B Arrest Report
- Level 7 – Group B Arrest Report Segment

Description:

This value is used to submit an initial Group B Arrest Report.

- Zero Report Segment
- Level 0 – Zero Report

Description:

This value is used to report that no crime occurred for a particular month.

2.3.6.2 M=Modify

Segment Action Type of "M" updates incident data already existing in the repository. If a record is submitted with a Segment Action Type equal to "M" and the record does not exist in the repository, MSHP will change the Segment Action Type to "A" for Add. The Patrol's backend processing will check to see if the incident was previously submitted, and if sent as "M" and not previously submitted, it will be changed to an "A" for repository processing. The newly submitted record will replace an existing repository record if it is sent as an "M". This may occur as a result of an agency or vendor internally correcting an incident and then submitting it for the first time. If the record does exist in our repository, the new record submitted will overlay the existing record in our repository.

Applies to:

- Group A Incident Report
- Level 1 – Administrative Segment

Description:

This value is used to modify Data Element 4 (Cleared Exceptionally) and/or Data Element 5 (Exceptional Clearance Date) in a previously-submitted incident or when an exceptional clearance is reported for a pre-NIBRS incident.

When the Incident Number is on file, Segment Action Type M = Modify will replace the existing data values for the incident in the database with the new data values, including new blank data values.

- Group B Arrest Report
- Level 7 – Group B Arrest Report Segment

Description:

This value is used to modify a previously-submitted Group B Arrest Report. All data elements submitted for this segment must reflect both the corrected and any unchanged values from the original submission. Segment Action Type M = Modify will replace the existing data values in the database with the new data values, including new blank data values

2.3.6.3 D=Delete

Segment Action Type of "D" deletes a record already existing in the repository. A "D" record should only be sent for a record submitted on a previous file. A record must not have Segment Actions Types of "D" and "A" submitted for the same incident on the same file. If during the period of time covered by a specific file, an incident was changed before it was first submitted, it should be submitted as an "M" or "A". If a corresponding record is not previously loaded in the repository, a "D" record will be treated as an error.

Applies to:

Group A Incident Report
Level 1 – Administrative Segment

Description:

This value is used to delete all data from the database that is associated with a Group A Incident Report.

When the Incident Number is on file, Segment Action Type D = Delete; deletes all data from the database that is associated with a Group A Incident Report.

- Group B Arrest Report
- Level 7 – Group B Arrest Report Segment

Description:

This value is used to delete the referenced Group B Arrest Report. When Data Element 40 (Arrestee Sequence Number) is submitted, only that arrestee will be removed from the system. When Data Element 40 (Arrestee Sequence Number) is left blank on the delete segment, all Group B Arrest Report data for that LEA, where Data Element 1 (ORI) and Arrest Transaction Number are the same as specified, will be removed.

- Zero Report Segment
- Level 0 – Zero Report Segment


Description:

This value is used to delete the Zero Report Segment in the system for the specified ORI (Data Element 1), Zero Report Month, and Zero Report Year.

2.4 File Testing

Before an agency can submit MIBRS data to the State repository, it must undergo compliancy testing. The MSHP will analyze incident data submitted during an agency’s test phase to determine whether its data meet MIBRS repository specifications. At least 3 consecutive months of test data with less than 4% error are required for an agency to be MIBRS compliant. An agency must continue to submit UCR Summary data during this MIBRS testing phase.

The agency should use the UCR Summary web application to submit or correct summary data. A listing of compliance scores by month will be provided on the MIBRS Web Facility.



3 Incident Reports

There are two categories of criminal offenses reported in the MIBRS incidents: Group A and Group B. It is important to determine which category an offense belongs because the reporting requirements for Group A and Group B offenses are different. Group A offenses must include relevant incident data represented in multiple segments (Administrative, Offense, Property, Victim, Offender, and Arrestee), whereas Group B offenses require only administrative and arrest data segments (Administrative, Arrestee). As previously indicated, an Administrative Segment must be submitted to MIBRS regardless of the Group Offense. Group A incidents can have Group B arrests attached to the same incident if the Group B arrest is part of the same Group A incident

Appendix A provides a listing of the offenses that fall under both Group A and Group B. MIBRS segments should be submitted for all incidents with Group A or Group B offenses committed within an agency's jurisdiction. A Zero Report Segment must be submitted to the repository if no offenses from either Group A or Group B occurred during an agency's report period.

3.1 Header Data Elements

Header Data Elements indicate the type of data in a submission. They appear at the beginning of each segment level to identify the segment and indicate the processing action required, as well as to connect all of an agency's data to a particular submission. These header data elements are:

- Segment Level

- Segment Action Type (Only include for the Administrative Segment and Zero Report)

- Submitting Agency ORI

- Incident Number

3.2 Group A Incident Reports

Each Group A Incident Report consists of seven (7) segment levels (Administrative, Offense, Property, Victim, Offender, Arrestee, and Group B Arrests). Each segment level consists of a number of data elements. The segment levels are briefly described and summarized below.

Level 1 – Administrative Segment

The Administrative Segment is the master segment. There is one Administrative Segment per Group A and/or Group B Incident Report. All other incident data relating to offenses, property, victims, offenders, and arrestees are contained in the other segments that are linked to the Administrative Segment by ORI and Incident Number.

The data elements used in the Administrative Segment are:

- 3. Cargo Theft (*Note: Cargo Theft data currently is not being collected in Missouri. However, blank spaces are added to file specifications for future inclusion of these data*).

- 4. Incident Date

- 5. Report Date Indicator

- 6. Incident Time (MIBRS collects the incident time as HHMM)

- 7. Cleared Exceptionally

- 8. Exceptional Clearance Date

3.2.1 Missouri Specific Administrative Elements

- M1. Domestic Violence-Related Incident
- M2. Domestic Violence Relationship
- M3. Latitude
- M4. Longitude

3.2.2 Level 2 - Offense Segment

The Offense Segment is used to identify and describe the types of Group A offenses involved in the incident.

The data elements used in the Offense Segment are:

- 10. UCR Offense Code
- 11. Offense Attempted/Completed
- 12. Offender Suspected of Using
- 13. Bias Motivation
- 14. Location Type
- 15. Number of Premises Entered
- 16. Method of Entry
- 17. Type Criminal Activity/Gang Information
- 18. Type Weapon/Force Involved
- 19. Automatic Weapon Indicator

3.2.2.1 Missouri Specific Offense Elements

- M3. Latitude
- M4. Longitude

3.2.3 Level 3 - Property Segment

The Property Segment provides information about the type, value, and for drugs and narcotics seized in drug cases quantity of property connected to a Group A offense involved in the incident.

The data elements used in the Property Segment are:

- 20. Type Property Loss/Etc.
- 21. Property Description
- 22. Value of Property
- 23. Date Recovered
- 24. Number of Stolen Motor Vehicles

3.2.8 Level 8 - Zero Report Segment

The Zero Report Segment is used when no crimes occurred in a LEA's jurisdiction for the reporting month.

Note: A UCR Program should not automatically generate the Zero Report Segment for a local LEA who does not submit crime data for a particular month. A UCR Program should ONLY submit the Zero Report Segment for a local LEA to communicate the fact that no crime occurred in their jurisdiction for the reporting period.

The absence of crime data does not mean that no crimes occurred. The MIBRS must differentiate between (1) a zero report – no crime occurred and (2) no crime information is submitted. The presence or absence of this record in conjunction with other available data will provide useful statistical information.

The data elements for this segment are:

- Zero Report Month
- Zero Report Year

Missouri UCR will give a 0% compliancy for any month an agency does not submit a file

4 Data Element Definitions

The data elements and data values identified in this section represent those required for participating in the UCR Program via the MIBRS. LEAs should use these data elements and data values to report incidents and arrests involving Group A offenses and for reporting arrests involving Group B offenses.

The FBI encourages participating agencies to include additional data elements and values in their own Incident-Based Reporting (IBR) systems to satisfy their own informational needs. However, agencies should report to the MIBRS only those data elements and data values that are listed in this section.

4.1 Data Elements

LEAs must use a series of established *data elements*, i.e., data fields, within each segment of the Group A Incident Report and in the Group B Arrest Report to describe the details of each component of a crime. Examples of these details include Incident Number, a UCR Offense Code, and Type of Victim.

4.2 Data Values

For each data element, reporting agencies should choose the most appropriate *data value(s)*, i.e., specific characteristics or types of the field being reported that have assigned codes. Although some data values require a specific format, most are codes from an approved list, each followed by an equal sign (=) and a description of the data value.

For example, for Incident Date, the specific format for the data value is YYYYMMDD. For Sex of Victim, agencies may enter one of the codes M = Male, F = Female, or U = Unknown to describe the gender of the victim; but for Sex of Arrestee, agencies can enter only M = Male or F = Female to describe the gender of the arrestee.

4.3 Data Element Descriptions

The data elements identified in the subsequent sections are grouped by the type of data they represent, e.g., administrative data, offense data, arrestee data.

The format and definition of the attributes of the data elements are the following:

Group: This identifies whether a data element is used in *only* the Group A Incident Report or both the Group A Incident Report and the Group B Arrest Report.

A = Group A

B = Group B

Format: This identifies the number of characters allowed for the data element in the segment and whether the characters must be Numeric, Alphabetic, or Alphanumeric.

Position: This identifies the physical position on the segment where the data element occurs. For example, Positions 56 – 57 indicates the data must be written beginning in the 56th position and ending in the 57th position in the segment.

Occurrence: This identifies how many times the data element occurs in a segment or incident.

Mandatory: Some data elements are required in order to have a complete/valid data submission, i.e., they are *mandatory*. Others are *conditional* based on the data values submitted for other data elements. Data elements that are reported at the discretion of the agency submitting the incident are considered *optional*.

Edits: This identifies specific conditions that must be met in order for the data element to be completed. The table includes a description of the edit as well as the associated error number. A numerical listing of Error Numbers with the associated Error Message and Error Description are located in Section 5. Error numbers are 4 character long and fall into 3 categories

FBI Errors

FBI errors are those in place from the FBI manual or derived from errors returned to MSHP from submission and are the error number is prefixed with a F.

Missouri Errors

Missouri errors are errors that are either edits from Missouri specific elements or edits on FBI elements that due to the addition Missouri elements, can be edited to a more specific degree.

Warnings

Warnings are on both FBI and Missouri elements that, while the elements are not in error, either the probability of the situation described by the combination of elements is slight, or the element's code is used as a placeholder until a more descriptive code can be entered.

Warnings are not counted against an agencies compliancy score but do need to be verified and/or corrected.

Positions

Position 1: Identifies the source of the edit. F= FBI, M=Missouri, W = Warning.

Position 2: Identifies the segment the error/warning originated from, or structural errors.

- 0=Zero Report,
- 1=Administrative
- 2= Offense

Position 3-4: Is the Missouri assigned element number

Data Values: This identifies the specific data values that are allowed in completing the data element.

4.3.1 File Name Elements

The File Name is comprised of several elements used for processing and recording of agency data. This name has to be constructed correctly to insure proper submission.

Submitting Agency ORI/MO#####: The agency’s ORI that is submitting the data.

Year/yyyy: This is the year the submission file created and also the year for which the agency is reporting the data but not necessarily the year the incidents in the file occurred.

Month/mm: This is the month the submission file created and also the month for which the agency is reporting the data but not necessarily the month the incidents in the file occurred.

Day/dd: This is the day the submission file created.

Hour/hh: This is the hour the submission file created.

Minute/mm: This is the minute the submission file created.

Version/vvvv: This is the Missouri MIBRS Specifications version used to create the file. If the version described in this publication was used, the value is 2-00

Format/f: The only valid code for format at the time of this publication is f=flat file.

4.3.2 Header Data Elements

Header Data Elements describe the type of data in a submission. They appear at the beginning of each segment level to identify the segment and indicate the processing action required, as well as to connect all of an agency's data to a particular submission.

Segment Length is not a field in the segment layout but rather the actual size of the line in the flat file. MIBRS does not have a Segment Length field; MIBRS checks the length of the segment according to the segment level. If the segment is not the correct length, the agency will get an error returned and no more validating will occur for that incident.

4.3.4 Offense Segment

The Offense Segment describes the various types of offenses involved in the incident and is submitted for up to ten of the most serious Group A offenses in the incident (as determined by the reporting agency). Only one Offense Segment should be submitted for each reported UCR Offense even though there may have been more than one victim of the crime. At least one Offense Segment must be submitted for each Group A Incident Report.

Each offense must be reported if it is a separate, distinct crime, rather than just a part of another offense. For example, every robbery includes some type of assault; but because the assault is an element that makes up the crime of Robbery, only Robbery should be reported. On the other hand, if during a robbery the victim is forced to engage in sexual relations, both Robbery and a Sex Offense should be reported, because sexual intercourse without the consent of the victim is not an element of Robbery.
